Windows Server 2012 R2 security evaluates these expressions and allows or denies access based on results of the evaluation. Securing access to resources through claims is known as claims-based access control. Claims-based access control works with traditional access control to provide an additional layer of authorization that is flexible to the varying needs of the enterprise environment.
